STEPS TO ENROLL FOR INTERNATIONAL STUDENTS

Congratulations on your acceptance to

the College of Saint Benedict and Saint John's University.

We hope that you will accept our offer of admission and become a part of the CSB/SJU college tradition.

STEPS TO ENROLL

To confirm your intention to enroll and to initiate the registration process, please follow the instructions below:

ADVANCE ENROLLMENT DEPOSIT

Once you have made your final decision to enroll, we require a non-refundable advance deposit of \$500 US Dollars. The deposit can be made online at: www.csbsju.edu/x1002 using a VISA or MASTERCARD. We also accept International money orders, cashier's checks, bank drafts or personal checks. DO NOT SEND CASH. Checks should be made payable to College of Saint Benedict or Saint John's University. This payment will be credited to your student account for tuition. You will be able to access the Enrolled Student Portal about one week after we have received your enrollment deposit. All required forms will be available in the Enrolled Student Portal, accessible at: www.csbsju.edu/x907. Please complete these forms in a timely manner, especially the housing form since this is used to assign you a roommate and residence hall.

PRIORITY DEADLINE

The National Association for Admission College Counseling (NACAC) requires U.S. colleges to "permit first-year candidates for fall admission to choose, without penalty, among offers of admission and financial aid until May 1." Because of strong interest in our colleges, we are unable to guarantee space for students seeking to enroll after this date. Students who seek to enroll after May 1 should be in contact with the Admission Office to determine the availability of space. Please contact the Admission Office if you have any questions.

FIRST TUITION PAYMENT

All new international students are required to submit the first tuition payment of \$2,500 U.S. dollars by June 1, 2013. This amount will be credited to your student account for tuition. Please follow the same method of payment instructions as mentioned in the Advance Enrollment Deposit section. The remaining amount due for tuition, fees, room and meals for the first semester will be due before your classes begin in August. This payment may be made in person after you arrive. NOTE: The tuition payment only will be refunded if you are unable to enroll due to student visa denial or extraordinary family or personal circumstances.

FINAL OFFICIAL ACADEMIC TRANSCRIPT

CSB/SJU require that your secondary school submit a certified photocopy of your final official academic transcript and/or external examination results that includes courses, marks or grades, rank in class (if applicable) and date of graduation. If you are transferring credits from another university, please bring complete course descriptions with you, translated in English if necessary.

ADDITIONAL STEPS

STUDENT VISA INFORMATION

If you are a citizen of a country other than the United States, you are required to obtain a student visa to study in the United States. Students will be issued an I-20 form by CSB/SJU after we receive the \$500 advance enrollment deposit. You will need the I-20 to obtain an F-1 visa. Canadian citizens do not need a visa, but they do need a passport and I-20 to enter the U.S. as a student.

- Upon receipt of your I-20, schedule a visa appointment at the nearest U.S. Embassy or Consulate that issues visas. An interview is required. Find the location nearest you at: www.usembassy.gov. Note "visa wait times." You may apply for your visa up to 120 days before the start date on your I-20.
- 2. Pay the SEVIS I-901 Fee. Anyone applying for an F-1 visa is required to pay the SEVIS fee. Plan to pay the fee at least 3 days prior to your visa interview. For more detailed information about the SEVIS fee, including options for payment, refer to: www.fmjfee.com/i901fee. Note: the SEVIS fee of \$200 USD is a separate fee from the visa application fee.
- 3. Upon receipt of the F-1 visa, you may enter the U.S., not more than 30 days prior to the start date on your I-20.

Receipt of an I-20 from the College of Saint Benedict or Saint John's University in no way guarantees that you will be issued a visa. In addition, receipt of an I-20 does not guarantee entry into the United States. Customs and Border Protection officers will inspect your immigration documents at the port of entry to determine your admissibility into the U.S. For additional information about non-immigrant visas and rules refer to: www.travel.state.gov.

To enter the U.S. you will need the following:

- 1. Passport valid for at least six months from the date you enter the U.S.
- 2. Valid F-1 student visa
- 3. I-20 from the College of Saint Benedict and Saint John's University
- 4. Documentation of funds sufficient to cover your first year at CSB/SJU (same documentation you used to apply for your visa)

PHYSICAL EXAM AND OTHER HEALTH REQUIREMENTS

Required health forms can be found at the Enrolled Student Portal. These must be completed prior to the beginning of classes and may be brought with you in August. Pay close attention to the required immunization forms. Minnesota laws are more stringent than most U.S. states.

HEALTH INSURANCE

All students are required to have a health insurance plan in order to attend CSB/SJU. CSB/SJU will enroll international students in a school-endorsed insurance plan through Student Assurance Services unless students indicate they have an alternative school-approved insurance plan (with minimum major medical coverage of \$50,000 U.S.). After submitting the \$500 enrollment deposit, complete the residence hall form in the Enrolled Student Portal, accessible at: www.csbsju.edu/x907.

Please note: the enrolled student portal will be accessible one week after we have received your enrollment deposit.
